DESCRIPTION


Non-economic damages are arguably the most difficult to present and for jurors to understand, since these may be visible or not visible. No two people will experience pain and suffering the same way; nor have the same pain and suffering response to the same provoking incident. Along the same lines, no two health care providers will document a plaintiff's pain and suffering complaints the same way, and some not at all. Thus, identifying and understanding evidence of pain and suffering as a result of injury, and the care required for treatment of the injuries can be a significant issue in your case.
